NOTICE OF INCREASE TO CERTAIN FEES ON THE DISTRICT COURT MISCELLANEOUS FEE SCHEDULE

At its September 2016 session, the Judicial Conference approved several changes to the federal court miscellaneous fee schedules¹.

As the result, **effective December 1, 2016**, the following listed fees on the District Court Miscellaneous Fee Schedule will increase:

1. Filing a Miscellaneous Matter will **increase** from **\$46 to \$47**;
2. Record Search will **increase** from **\$30 to \$31**;
3. Exemplification of any Document or Paper will **increase** from **\$21 to \$22**;
4. Reproduction of Recordings will **increase** from **\$30 to \$31**;
5. Appeal to District Judge from Judgment of Conviction by a Magistrate Judge in a Misdemeanor Case will **increase** from **\$37 to \$38**;
6. Attorney Admissions to Practice (includes certificate) will **increase** from **\$186 to \$191**;
7. Pro Hac Vice motion admission application fee will **increase** from **\$93 to \$96**;
8. Duplicate Certificate of Admission or Certificate of Good Standing will **increase** from **\$18 to \$19**;
9. Filing an Action under Title III of the Cuban Liberty and Democratic Solidarity (LIBERTAD) Act of 1996 will **increase** from **\$6,355 to \$6,548**; and
10. Management of Registry Funds Fee:
 - a. CRIS Disputed Ownership Funds (28 USC 1335): Annual rate of 20 basis points (20%) of assets on deposit shall be assessed from interest earnings.
 - b. All other CRIS Registry Funds: Annual rate of 10 basis points (10%) of assets on deposit shall be assessed from interest earnings.
