ORDER

This matter is before the Court upon the request of the Hon. Robert L. Miller, Jr. on behalf of the Hon. James Rosenbaum for a temporary exemption from the fees imposed by the Electronic Public Access Fee Schedule adopted by the Judicial Conference of the United States Courts for the purposes of the Hon. James Rosenbaum's performance of duties associated with his appointment as Special Master in Cause No. 3:05-MD-527 and its associated cases.

The Court finds that the Hon. James Rosenbaum, as Special Master appointed in Cause No. 3:05-MD-527, falls within the class of users listed in the Electronic Public Access Fee Schedule appended to 28 U.S.C. § 1914 as being eligible for a fee exemption. Additionally, an exemption is necessary in order to avoid unreasonable burdens in the performance of the Hon. James Rosenbaum's duties as the appointed Special Master in Cause No. 3:05-MD-527 and its associated cases.

ACCORDINGLY:

The Hon. James Rosenbaum shall be exempt from the payment of fees for access via PACER to the electronic case files maintained in this Court, to the extent such use is incurred in the course of his performance of duties as Special Master in Cause No. 3:05-MD-527 and its associated cases. The Hon. James Rosenbaum shall not be exempt from the payment of fees incurred in connection with other uses of the PACER system in this Court. Additionally, the

following limitations apply:

1. This fee exemption applies only to the Hon. James Rosenbaum and his case manager, Debra Lewis, and is valid only for the purposes stated above, and not for commercial purposes or internet redistribution;
2. This fee exemption applies only to the electronic case files of this Court that are available through the PACER system;
3. By accepting this exemption, the Hon. James Rosenbaum and his case manager, Debra Lewis, agree not to sell for profit any data obtained as a result of receiving the exemption;
4. The Hon. James Rosenbaum and his case manager, Debra Lewis, are prohibited from transferring any data obtained as the result of the fee exemption unless expressly authorized by the Court;
4. Unless extended by further order, this exemption will expire **at the termination of the Hon. James Rosenbaum's duties as Special Master in Cause No. 3:05-MD-527 and its associated cases.**

This exemption may be revoked at the discretion of the Court at any time.

The Clerk is directed to send a copy of this Order to the PACER Service Center and to the Hon. James Rosenbaum.
