

RESOLUTION OF THE UNITED STATES DISTRICT COURT
FOR THE NORTHERN DISTRICT OF INDIANA

WHEREAS, Rodolfo “Rudy” Lozano, a remarkable public servant, did serve his state and country with distinction as a United States District Judge for the Northern District of Indiana from February 26, 1988 until July 11, 2018; and

WHEREAS, Rodolfo “Rudy” Lozano became a senior judge on July 10, 2007, yet retained a full caseload until his death on July 11, 2018; and

WHEREAS, Rodolfo “Rudy” Lozano was the first Hispanic federal district judge to be appointed in Indiana and the first Hispanic federal district judge appointed in the Seventh Circuit; and

WHEREAS, Rodolfo “Rudy” Lozano was a highly respected lawyer during his years in private practice from 1966 until 1988; and he was a leader and role model for all lawyers in the legal profession throughout his legal career; and

WHEREAS, Rodolfo “Rudy” Lozano was instrumental in the design and construction of the United States Courthouse at 5400 Federal Plaza, Hammond, Indiana, and did so while maintaining a full caseload of criminal and civil cases.

NOW, THEREFORE, BE IT RESOLVED, that the court on this date has determined to honor the historic life, career, and legacy of Rodolfo “Rudy” Lozano and to give testimony to his remarkable stewardship in the courtroom, and to recognize his significant contributions to the design and construction of the Hammond Courthouse and the courtroom in which he presided from 2002 until 2018. Thus, the court hereby Designates and Dedicates to the honor of its judicial brother, Judge Rodolfo “Rudy” Lozano, the 4th floor courtroom of the United States Courthouse at 5400 Federal Plaza, Hammond, Indiana, in which he presided, as “The Rodolfo “Rudy” Lozano Courtroom” by which it shall henceforth be known and outside of which shall be hung his official portrait along with an appropriate plaque memorializing this occasion and this Resolution.
