General Order No. 2022-17A

GENERAL ORDER

This Order SUPPLEMENTS General Orders 2022-17, 2022-11, 2022-05, 2021-31, 2021-24, 2021-19; 2020-05; 2020-06; 2020-07; 2020-08; 2020-10; 2020-14B; 2020-18; 2020-20; 2020-29; 2020-32; 2020-35; 2020-39; 2021-03; 2021-04; and 2021-10. To the extent this Order differs from those Orders, this Order supersedes and replaces those Orders.

IT IS HEREBY ORDERED that based on the information available to date, including the estimated number of persons infected currently with COVID-19 and the number of cases projected to occur in the immediate future, the Court REAFFIRMS the following findings made in General Order 2020-05:

1. The gatherings of people in close proximity to one another that occur during Court operations presents the potential for substantial health risks to the public;
2. Such risks may be significantly mitigated by temporarily modifying Court operations; and
3. Good cause exists to implement temporary changes to Court operations.

Therefore, it is hereby ORDERED that the authorization for use of video teleconferencing, or telephone conferencing if video conferencing is not reasonably available, for the instances described in General Order 2020-08 is **EXTENDED** from September 6, 2022, until **December 5, 2022**, in all of the Court's divisions:

1. In criminal proceedings:
  - a. The United States District Court for the Northern District of Indiana resumed jury trials and reopened the Clerk's offices of the District to the public on March 1, 2021. However, the State of Indiana website [coronavirus.in.gov](https://coronavirus.in.gov) as of August 25, 2022, at 11:59 p.m., shows the 7-day average of all confirmed Covid-19 infections in Indiana at 2,047; there have also been 838 hospitalizations involving Covid-19, which represents a 6% increase over the previous 7-day average; in addition, during the current tracking period, 6 confirmed Covid-19 deaths have been reported.<sup>1</sup> Huntington, Cass, Benton, White, and DeKalb County are the

<sup>1</sup> According to the website, on March 30, 2022, the Indiana Department of Health (IDOH) announced changes to its COVID-19 dashboard to align with national reporting measurements and better reflect the impact the pandemic is having on communities and healthcare systems. The website no longer reflects a daily positivity rate. Instead, the

counties with the greatest number of Covid-19 infections per 10,000 residents. Moreover, on February 18, 2022, the President of the United States notified Congress that COVID-19 continues to cause significant risk to the public health and safety of the nation and, on February 23, 2022, published formal notice in the Federal Register continuing the national emergency concerning the coronavirus pandemic. The threat presented by COVID-19 and its spread remain very real concerns and continue to create exigent circumstances; therefore, the Chief Judge finds that felony pleas and felony sentencings cannot be conducted in person without seriously jeopardizing public health and safety. As such, the presiding judge should be given discretion in determining whether to conduct such matters in person.

- b. To the extent criminal proceedings may be conducted via phone or videoconference in accordance with General Order 2020-08 and Section 15002 of the CARES Act, in-person proceedings may be converted to telephonic or videoconference proceedings by the assigned District or Magistrate Judge after consultation with counsel. On a case-by-case basis and at the discretion of the assigned District or Magistrate Judge, criminal proceedings may be conducted in person after consultation with counsel and the United States Marshal Service.

General Orders 2020-07 and 2020-08 further address criminal proceedings held before the Magistrate Judges in light of the exigent circumstances created by the COVID-19 pandemic. The Chief Judge extends the authorization for use of video teleconferencing, or telephone conferencing if video conferencing is not reasonably available, for the instances described in General Order 2020-08 from September 6, 2022, until **December 5, 2022**.

**HOWEVER, it must be emphasized that it is the district's very strong preference that judges conduct such proceedings while present in their respective courthouses. Their consistent presence in the courthouses will foster the effectiveness and efficiency of court operations.**

IT IS FURTHER ORDERED that this Order is in effect until further order of the Court.

dashboard displays a seven-day average of cases and indicates whether that number is trending up or down. The dashboard also ceased publishing the state's county and advisory metric maps and instead follows the community transmission measurements recently announced by the Centers for Disease Control and Prevention. The changes reflect a national shift toward using hospitalization data as the leading indicator of the impact that COVID-19 has on a community.
