WHEREAS, Andrew P. Rodovich taught Criminal Law and Evidence as the Distinguished Jurist in Residence at the Valparaiso School of Law from 2013 to 2016; and

WHEREAS, Andrew P. Rodovich received multiple awards and honors during his 40 years on the bench including being a recipient of the Sagamore of the Wabash (2002) and Indiana Trial Judge of the Year (2013); and

WHEREAS, Andrew P. Rodovich was a leader and role model for all lawyers in the legal profession throughout his legal career.

NOW, THEREFORE, BE IT RESOLVED, that the court on this date has determined to honor the life, career, and legacy of the Honorable Andrew P. Rodovich and to give testimony to his remarkable stewardship in the courtroom and service to his community, the State of Indiana, and the United States of America. Thus, the court hereby Designates and Dedicates to the honor of its judicial brother, Judge Andrew P. Rodovich, the 3rd floor courtroom (southwest side) of the United States Courthouse at 5400 Federal Plaza, Hammond, Indiana, as "The Andrew P. Rodovich Courtroom" by which it shall henceforth be known and outside of which shall be hung his official portrait along with an appropriate plaque memorializing this occasion and this Resolution.
