All Panel members have been advised in writing of the restriction set forth in §420.30.20(d)(1) of the Regulations of the Judicial Conference of the United States Establishing Standards and Procedures for the Appointment and Reappointment of United States Magistrate Judges with respect to the one-year period that must separate such service and consideration for an open magistrate judge position. The Merit Selection Panel shall convene and meet as necessary to review the applicants for the position, to consider their personal characteristics and professional qualifications, and to conduct such interviews as they deem appropriate (while maintaining the

requirement of confidentiality). On or before **March 8, 2024**, the Panel shall submit to the Court their report designating the five applicants whom the Panel finds most qualified to serve the Northern District of Indiana as a United States Magistrate Judge.
