GENERAL ORDER

Due to a lapse of congressional appropriations funding the federal government, courts have

been asked to delay or defer non-mission critical expenses, although judiciary employees are

reporting to work because they are necessary to support the Court's mission critical work.

Similarly, the Department of Justice's FY 2026 Contingency Plan, see

www.justice.gov/jmd/media/1377216/dl, indicates that civil litigation will be curtailed or

postponed to the extent that this can be done without compromising to a significant degree the

safety of human life or the protection of property. Criminal cases are expected to proceed

uninterrupted. The Court, in response, and with the intent to avoid any default or prejudice to the

United States or other civil litigants occasioned by the lapse in funding, sua sponte enters this

General Order. Social Security cases, as identified in the attachment to this General Order, shall

have their October response brief deadlines extended thirty (30) days from the date currently set.

Reply briefs will be due fourteen (14) days after the response brief is filed. Civil cases not

identified herein (including other Social Security cases) remain unimpacted; however, this order

does not limit the ability for litigants to request extensions of time in individual cases.

Any litigant affected by this General Order may seek relief from the order by motion. The

Court may, in any particular case, vary the effect or operation of this General Order by a separate

ruling.

The Court shall distribute this General Order:

(a) by electronic service to all registered CM/ECF litigants registered and having

appeared in the cases identified above;

(b) by first-class mail to unregistered civil litigants, including pro se litigants, having

appeared in the cases identified above; and

(c) by posting the General Order on the Court's public website.
