ORDER ACTIVATING DISCOVERY GROUP 8A

Having reviewed the parties' jointly submitted case list, the Court activates the pool of cases listed on **Exhibit A** as Group 8A for case-specific discovery.

Completed and updated medical records authorizations for Group 8A cases shall be provided to Biomet by **May 1, 2019**.

The parties may engage in case-specific discovery relating to the Group 8A cases until **December 12, 2019**. Such discovery may include interrogatories, requests for production, requests for admission, and depositions of (a) the plaintiffs, (b) the implanting surgeon, (c) the revising surgeon, (d) the Biomet representative who processed the request for the product used during the implant surgery, (e) any separate Biomet representatives who were present in the operating room during the implant or revision surgery, and (f) one additional fact witness per side. The depositions will be scheduled in conjunction with a plaintiff's counsel of record, who should expect to represent the plaintiff at the deposition; the PSC may, but isn't required to attend these depositions.
