MEMORANDUM OF JANUARY 28, 2016 TELEPHONIC STATUS CONFERENCE

Topics addressed at the January 28 telephonic conference included the number of cases still pending in this litigation and the status of pending motions. Biomet advised the court that there were currently around 280 active member cases and approximately 600 cases that have been settled, but have yet to be dismissed. Court records, however, indicate that there are currently over 1200 open cases, of which only 143 were reported settled as of December 7, 2015 (*see attached*).

Following discussion, the court:

(1) DIRECTED counsel for the Biomet Defendants to identify which of the cases on the attached list remain active as of the date of this order, and to file an updated list in the master case, Cause No. 3:12-MD-2391.

(2) SET a telephonic status conference for **Monday, March 14, 2016, at 2:00 p.m. (E.D.T.)**.
